Green City Market updated us on their program for 2012. They will have the same schedule as 2011 starting in May and going through October. Composting is the big new program for the market. The composting garbage will be removed each market day by the city's composting vendor. Green City is pleased because it helps with their mission. The only trash bins that will be in the area are those that would normally be there. The farmer's trucks will be relocated to Stockton (the Alderman and CDOT have worked together on this plan). Load in will occur on Clark at the market entrance. The truck parking south on Clark will be maintained and the refrigerated trucks will be on Stockton. Plans are being developed with the Chicago Park District to reduce the impact of the mulch on the landscape.

Additionally, while developing the new plan for truck parking, allocations on Stockton for parking, loading and disabled parking spaces were reviewed and proposed changes are being reviewed. Maps pf the changes will be posted on the LPAC website.

Everyone expressed appreciation to the Green City Market for taking the issues seriously and creating good solutions to the problems. Concern was expressed about the prepared food vendors. It was stressed that the prepared food showcases the food for sale on site. They will be more concerned about the use of generators on site as they select the vendors for 2012.
