PRESENTATIONS

Mitch Murdock, Natural Areas Manager, Chicago Park District

Improvements are planned for Montrose Point and the Marovitz Savanna area (attachments on website). ADA access paths and fencing were discussed at length. It is CPD's goal to have the paths constructed using materials that are as natural-looking as possible while handicapped-usable. Several natural areas volunteers from Montrose offered detailed feedback for the Park District.

Despite a general desire to avoid fencing in the parks, there is a need for some fencing at natural areas. In the Montrose Point area the fencing will delineate areas where the access hours differ from the park in general, thus allowing the police to take action on the illegal activities. Fences also stop the grass-mowers who often don't notice the border between turf and natural grass. In the Marovitz area some fencing is needed to deter trespassers.

LPAC Meeting

The LP Cultural Center has a new art instructor, which has expanded class offerings greatly.

Thirteen Terrors –the haunted house at Theater on the Lake—will take place the last two weekends of October. Parking will be free at the nearby harbor lots. CPD is expanding its marketing of the event to include things like Groupon sales.

There was a lengthy discussion about various areas where paths needs to be repaired/replaced.

Sandy is still seeking information on where the money from the Nike project is being spent – per a request from Sheli Lulkin.

Marc Kramer commented to Sandy that the general maintenance of the Grandmother's Garden area was much improved this past summer.

Sandy explained that CPD has a big problem with garbage cans being stolen.

3. Park Liaison report

The Park Commissioners approved the use of online "reverse auction" purchasing process for services and commodities. This means that bidders no longer submit a single sealed bid but rather go through an online process whereby they can rebid lower prices against their competitors. This not only leads to lower purchase prices for the buyer (the Park District) but also reduces staff overhead. The company contracted to run the online service is currently used by the City of Chicago.
